Deferrals will NOT be offered on Personal Lines of Credit, Mortgage Loans, E-Z Cash Loans, Overdraft Protection, Single-Payment Share/CD Pledge Loans and VISA. You may only defer the same loan payment ONE TIME during the Skip Payment promotion. Deferrals will NOT be offered on any loans that have been delinquent or are delinquent now. All requests are subject to ODFCU approval. Must meet credit requirements. Thirty dollar fee per loan.

By participating in Omaha Douglas Federal Credit Union's (ODFCU) Skip Payment program, you request that ODFCU defer your loan payment(s) as indicated. You agree and understand that: (1) Finance charges will continue to accrue at the rate provided in your original loan agreement, during and after this time. (2) Deferring your payment will result in higher total finance charges than if you made your payment as originally scheduled. (3) The payment deferral will extend the term of your loan(s) for one month beyond contracted maturity date. (4) You will be required to resume your payment(s) the following month. (5) The original terms of your credit insurance (if any) will remain the same.
